Dear Mr. Talreja,

This refers to your 1st request for review of Submission-3 regarding the recruitment of Consulting Services for the preparation of Sindh Road Network Master Plan, including Institutional Strengthening Trainings, received on 11 June 2018 for our review and endorsement. ADB received the revised Financial Evaluation Form-7 of technical proposal from Project Management Unit (PMU) on 20 June 2018.

After review, ADB accords approval of Submission-3. Please proceed with the contract negotiations with the first ranked firm M/s Engineering Consultants International (Pvt) Ltd.

Please note that (i) before proceeding with contract negotiations, the consulting firm needs to confirm the availability of all team members nominated in its proposal as a pre-requisite to the negotiation; (ii) submit the CVs that are signed by the experts themselves; (iii) replacing personnel may be considered when the proposed team become unavailable due to reasons beyond the firm's control (for example illness, death, or family difficulties); and (iv) replacement must have equal or better qualification and experience than the original expert.

The PMU requests replacement of personnel if an expert has received a low score, is ineligible or was rated poorly for a previous consulting assignment. The remuneration charged for the replacement expert should remain the same as that proposed for the original expert.

The firm invited to negotiate shall submit to PMU a letter of authority identifying the firm's representative who shall be authorized to negotiate and sign the contract, as well as a copy of the firm's legal certificate of incorporation of establishment.

The PMU shall include the following agenda items in its invitation letter to the consulting firm.

submitting written authorization for the consultant to negotiate and sign a contract with PMU;

- ii. reviewing documentation submitted, including the financial proposals, review of project matters such as, scope of work/TOR, work plan and personnel schedule, counterpart staff and facilities, and/or equipment

- vi. Discussing contract administration and monthly progress reports.
